5.2 Deputy Mayor

Committee members agreed to each serve a term of eight (8) months as Deputy Mayor. The first term will be served by Councillor Smith, followed by Councillor den Haan, then Councillor MacMurtry. Those serving the remaining terms will be decided at a later date.

5.3 Committee Appointments
